Subjects in English

Students in the Degree in Labour Relations and Human Resources have the opportunity to take some subjects in English.

Doing subjects in English is valued as a merit during the selection process for ERASMUS scholarships for placements in European universities and appears in the European Diploma Supplement (DS).

Internships

In the Degree in Labour Relations and Human Resources, internships are structured as an elective subject with 12 ECTS. Internships are offered in the most important companies and institutions in the region.

International Mobility*

Students in third and fourth year can spend one semester or a full academic year in a foreign university with which the School of Economics and Business has a bilateral agreement. At present, the School has ERASMUS agreements with over 50 universities in 15 European countries, permitting students to study in five different languages: English, French, German, Italian and Portuguese.

Apart from ERASMUS agreements, which are specific to students from the School, the University of Oviedo has several cooperation agreements with non-European universities, mainly from the Americas, many of which are open to students from the School.

JOINT DEGREE IN BUSINESS ADMINISTRATION AND MANAGEMENT & LAW

Objectives

The objective of the Degree in Business Administration and Management is to train professionals who will be able to perform managerial and decision-making roles in different areas of companies or in the public administration. The objective of the Degree in Law, on the other hand, is to provide the knowledge and skills necessary to correctly deal with the legal issues and problems faced by individuals and firms.

The combination of these two degrees will provide graduates with capabilities and competences to:

- Identify business initiatives and bring them to fruition.
- Manage and administrate companies and public and private institutions.
- Carry out duties and tasks in any of the divisions of the company: accounting and management control, legal services, supply chain management and marketing, operations, or human resources.
- Work as an independent professional (lawyer, solicitor, consultant,)

Graduates in Business Administration and Management & Law can pursue professional careers in both the public and private sectors as well as in international entities. Either of these two degrees permits graduates to prepare competitive exams to enter Civil Service bodies (at regional, national and European levels) which require legal and/or economic training.

Applicant profile

To enter the Joint Degree in Business Administration and Management & Law, students should demonstrate an interest in getting to know and understand the workings of the business world and the economy in general, as well as an interest in and respect for the law and social norms. Students should possess a series of aptitudes including: an entrepreneurial outlook; adaptability and flexibility; willingness to negotiate and powers of persuasion; aptitude for handling and interpreting quantitative information; good oral and written communication skills; critical and reflexive outlook; information technology skills; analytical capabilities and good intuition; good memory and powers of concentration; and willingness to learn languages, especially English.


